#### **Objectives**

- ✓ Demonstrate his or her knowledge of and ability to use basic Bible study aids such as a concordance, a word study dictionary, a Bible dictionary, a Bible encyclopedia, and Bible commentaries, including online sources;
- ✓ Articulate the basic kerygma of the New Testament; and
- ✓ Demonstrate a nuanced understanding of the Gospel as understood from the perspectives of each of the Evangelists.

Brown, a Roman Catholic priest, analyzes each of the 27 books in the New Testament, devoting painstaking attention to sources, dates, and authorship, as well as commentary on the spiritual, historical, and thematic aspects.

Johnson, Luke Timothy. *The Writings of the New Testament*. Minneapolis, MN: Fortress Press, 2010.

Johnson deftly guides his reader through a wealth of historical and literary description, and invites critical reflection on the meaning of these ancient writings for today.

Arranged historically, Drane's text takes readers through the world of the first Christians, the life and teaching of Jesus, the origins and growth of the Early Church, the life, mission and letters of Paul, how the Gospels were composed, Revelation, and how the New Testament was formed and has been interpreted and used by later generations.

#### **HOLY SCRIPTURE**

#### Mentor: The Rev. Remington Slone

- 1) During your time of preparation for the diaconate, read the entire Bible, including the Apocrypha, using one of the Episcopal Church-approved translations. Make entries in a journal (style of your choosing) noting significant themes, ideas, and spiritual insights found in each book.
- 2) Read *considerable portions* of the major divisions of the two required books on the Old Testament. In a 5-10 page paper, summarize the major sections of the Old Testament as they are described in these works. Please note the major features of the Old Testament which have captured your attention.
- 3) Read *considerable portions* of the major divisions of the two required books on the New Testament. In a 7-10 page paper, summarize the major sections of the New Testament as they are described in these works. Please note the major features of the New Testament which have captured your attention.
- 4) Using the two required books on the New Testament, select one passage of scripture held in all three of the synoptic Gospels (the triple tradition). In a 5-7 page essay, compare and contrast this passage in each of the traditions, making note of their key similarities, differences, and importance to the Evangelists' thesis.
- 5) Choose a portion (pericope) of scripture in the New Testament to exegete (agreed upon with your Module Four mentor). Develop a lesson for an adult Bible study in your parish. The lesson should be designed to prepare your congregation to more deeply understand justice and mercy from a Biblical perspective. Use your ministry in the world as an example of either justice or mercy ministry, and explain how scripture supports this ministry. Be prepared to teach this class at Deacon School.
- 6) Explain the evidence for the diaconate/order of deacons in the Book of Acts and the New Testament Epistles. Write a 3-5 page paper explaining the roles deacons played and the importance of their roles.
